Will County ETS Celebrates National 9-1-1 Education Month and National Public-Safety Telecommunicators Week

During April, the Will County Emergency Telephone System joined municipalities, governmental bodies and organizations across the U.S. in recognizing the vital role played by telecommunicators in helping to ensure public safety.

In order to encourage such recognition, the United States Congress and the National Emergency Number Association (NENA) designated April as National 9-1-1 Education Month. And the week of April 12-18 was celebrated as National Public-Safety Telecommunicators Week.

As a result, this special issue of Dispatch Dialogue is devoted to acknowledging some of the special events that took place last month to honor these special people in Will County.

Shari Reinbacher Is Will County Telecommunicator of the Year

One special event took place on April 23, when the 9-1-1 Board honored Romeoville's Shari Reinbacher as Will County Telecommunicator of the Year for 2009.

Employed by the Village of Romeoville since 2005, Reinbacher was nominated for this recognition because "she displays a positive and proactive approach to dispatching on a daily basis," according to Romeoville Dispatch Center Director Kim Knutsen, who added that she is a "true asset."

Reinbacher is considered "an exemplary training officer" who is "patient, explains policies and procedures in depth, and encourages trainees to set specific and measurable goals," said Knutsen when nominating her. "She exhibits a positive attitude toward training and" *(Continued on page 2)*

respects the opinions, abilities and contributions" of her co-workers.

In her nomination of Reinbacher, Knutsen also indicated that she "displays strong leadership skills and recognizes the importance of shared knowledge.

"She is assigned to the busiest shift (afternoons) and handles (its) high volume of calls with tact and humor," according to Knutsen. "The officers she works with have an unspoken trust in her abilities and openly accept her as one of the team."

In January 2008, Reinbacher received a Romeoville Police Department commendation for her handling of a third-party call from a suicidal subject.

She was able to convince the caller to allow the Police Department to help him. As a result of her "patience and determination, there was a positive outcome," Knutsen said.

Also, in July 2008, Reinbacher was nominated for a commendation after responding to a call from the victim of an armed robbery at a local business.

She was "able to effectively coordinate the police response, while conducting herself with the utmost

professionalism and compassion as she maintained communications and consoled the victim until responding officers arrived on the scene," said Knutsen.

Another noteworthy response mentioned in Knutsen's nomination was a call regarding a large fight involving several hundred partygoers, which was handled by Reinbacher and her peers in March 2009.

"Shari maintained radio contact with responding officers as she assisted her co-workers with notifications to request emergency assistance," said Knutsen. "As always, Shari performed well under pressure and displayed a calm demeanor."

In addition to being honored as Will County Telecommunicator of the Year, Reinbacher will receive an all-expenses-paid trip to the 2009 Illinois NENA/APCO Conference – October 18-21 – in Springfield.

Sheriff's Office Nominates Carol Adair

In addition to Reinbacher, the 9-1-1 Board honorably mentioned Will County Sheriff's Department Senior Telecommunicator Carol Adair,

who also was nominated for the annual award.

A dispatch veteran with 31 years of service to the Sheriff's Office, Adair was commended for "her calming demeanor, professionalism, and knowledge – above and beyond what words can describe.

"She continues to be a true asset to the Sheriff's Office not only for her qualifications as a 9-1-1 operator and training officer, but also as a member of the Critical Incident Stress Debriefing Team," said Sergeants Mark Rojkowski and Mark Fisch, supervisors of the 7a.m. to 3 p.m. shift.

"Carol's cheerful personality and unwavering ability to handle the day-to-day demands of her job have proven her to be a real role model to newly hired telecommunicators," they said.

Also, Adair was lauded for her "dedication to the safety of all the deputies on her shift...and the citizens needing assistance." ●

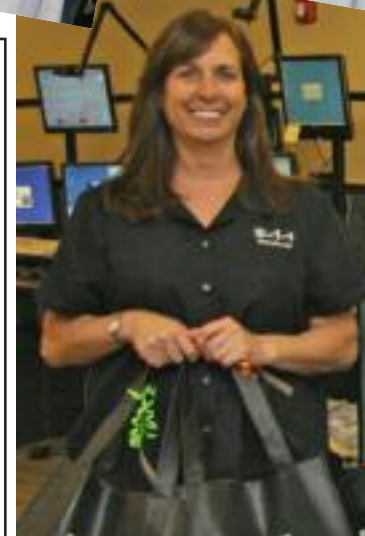

versatility, creativity, strong work ethic, great sense of humor and good “old school” common sense are just some of the characteristics that she exhibits in the course of doing her job.

“As our ‘reluctant hero,’ she aggressively shuns the spotlight, but never shuns any task to which she is assigned,” said Joliet Communications Center Director Julie Ponce-Doyle. “A simple ‘thank you’ is the only reward she requires.

“Traci is one of our most multi-faceted telecommunicators,” said her shift supervisor, Zelda Scott. “At some point in her career, she has been a part of almost every program and specialized training our center has initiated. She takes great pride in producing the highest quality work, something that we all rely on.”

Farley has served as a CTO; a member of Joliet’s TERT Team; and as a contributor to the center’s 9-1-1 public education efforts. And she has provided technical assistance to the center’s IWIN/MDT program and operator training on its Reverse 9-1-1 system.

Also, “most notably,” according to Public Safety Dispatcher Denita Draper, “she has been our LEADS Coordinator since 2005. As such, she is responsible for the accuracy and maintenance of LEADS files and entries, including validations; LEADS training activities and the development of related training tasks; and sex-offender registry, related files, and coordination with the Investigations Division. Further, she is responsible for maintaining data/LEADS certification for approximately 400 civilian/sworn members of the Joliet Police Department.”

“While Traci doesn’t need any recognition for her hard work, her award of Telecommunicator of the Year is overdue,” said Ponce-Doyle. ●

both the fire and police sides whenever needed.”

She also is described as “an awesome trainer” – especially when it comes to “call-taking training, which is one of the hardest things to teach.” And she is “patient and encouraging with new trainees.”

Perhaps that’s because, at times, she is a trainee herself. For example, she has been cross-training on the po-

lice side, even though it takes considerable time and persistence.

Although it’s not always easy to get along with co-workers, who have so many strong personalities and work in a small area under stressful circumstances, Savage does so “with ease and everybody enjoys working with her,” according to one of her peers.

Other personal and professional attributes credited to Savage by her co-workers include:

- *Exceptional dedication with a professional image*
- *Handles pressure well – e.g., standing strong during critical incidents*
- *Kind and patient with callers and trainees*
- *Willing to ask for and give help*
- *Not afraid to speak up*
- *Can give tough love when it is needed*
- *Admits when she has made a mistake and learns from it*
- *Eager to learn and teach*



While all of these attributes are worth acknowledging, perhaps one WESCOM co-worker says it best: “I think my life – and many other lives – are better because of Janice.” ●
